# 6. TO APPOINT BDO AS AUDITORS

# 7. CHAIR'S UPDATE

The Chair reflected on the impact of Covid on Haberfield. She added that a profit of \$75k was made last year in which \$15k was received from ATO subsidies and \$48k from Job Keeper payment. The Chair congratulated the management and the staff for achieving these results in the difficult circumstances due to Covid. By the end of last year, the club was open for lunch and dinner from Friday to Sunday which helped in extending the hours which was also a reaction to community input. The Chair highlighted that despite a slow start of the year and weather impact, the club has been performing well. The Chair added that the club will be in a stronger position this year as the circumstances are changing back to normal. The Chair mentioned that Haberfield is working more closely with the Rowing Association as well.
